CPR and CPI Classes Offered:



Innovative Healthcare will be conducting both CPR and CPI recertification courses over the next two months. Both trainings will be conducted at 1616 East Roosevelt Road, Ste #4, Wheaton IL 60187
Capacity for both of the classes is six participants.

We have scheduled our CPI courses for the following dates:

Saturday, May 17th 9:00 a.m. to approximately 1:00 p.m.
Tuesday, June 3rd 5:00 p.m. to approximately 9:00 p.m.

We have scheduled our CPR courses for the following dates:

Tuesday, May 13th 5:00 p.m. to approximately 9:00 p.m.
Saturday May 31st 9:00 a.m. to approximately 1:00 p.m.

The CPI course is provided by the Crisis Prevention Institute at a cost of \$25.00 for Innovative Healthcare employees, \$35.00 for non employees. The CPR course is provided by the American Heart Association at the same costs.

Both courses can be paid for by cash, personal check, Visa/Mastercard, American Express or Discover. All payments should be made out to Innovative Healthcare.

The CPI recertification course certifies the participant for one year from the date of the course. The American Heart Association CPR recertification course certifies the participants for two years from the date of the course. As you are aware, both CPI and CPR certifications are requirements for our employees to work within the hospitals and clinics we service.
